## Step 8: INCOME TAX WITHHOLDING (THIS SECTION MUST BE COMPLETED\*) (Form W-4/OMB No. 1545-0415)

Please note that penalties may be incurred under the estimated tax rules if your withholding and/or estimated tax payments are not sufficient.
